Academic Senate Resolution

Second Reading

Exec 18-10 Resolution Calling for Timely Notice and Scheduling of MPP Campus Visits

RESOLVED: That open forums for the following MPP positions:

- All Level IV Administrators¹
- Academic Affairs Administrators Level III²
- Level III Administrators for:
- AVP of Communications & Marketing, Associate Vice President Enrollment Management, Associate Vice President of Student Affairs, Associate Vice President of Student Success, Athletics Director, Chief of Medical Services, Chief of Police, Director of Employee Relations, Director of Financial Aid, Director of Student Health Center, Senior Director University Effectiveness Planning & Analytics, Senior Associate Vice President for University Advancement, Title IX Officer³

be scheduled during periods when regular classes are scheduled; and be it further,

RESOLVED: That chairs of search committees for the above mentioned MPPs, as part of overall search planning, identify when the anticipated open forums would likely occur and communicate this information to the President's Office or Academic Affairs and to the Senate Executive Committee; and be it further,

RESOLVED: That advance notice of the *expected* dates for campus open forums be provided by the President's Office or Academic Affairs at least two weeks before a campus visit; and be it further,

RESOLVED: That at least one week's notice be given for the date and times of each of the open forums once finalists are chosen; and be it further,

RESOLVED: That consideration be given to scheduling forums at times that allow for the greatest participation by campus stakeholders; and be it further,

RESOLVED: That upon passing the resolution it be distributed to the President, Provost and Vice President of Academic Affairs, Vice Provost, Vice President of Administration and Finance, Vice President of Student Affairs, Vice President of University Advancement, the Vice President of Information Technology; the Deans of the College of Arts & Humanities, the College of Education, the College of Natural and Behavioral Sciences, the College of Extended and International Education, the College of Health, Human Services & Nursing, the College of Business Administration and Public Policy, and the Library; all faculty and staff, and the ASI President.

RATIONALE

Considering the critical nature of managerial positions, and the need to provide students, staff and faculty with the opportunity to participate in the selection process, all MPP finalists should be scheduled for campus visits during the semester when classes are in session. This resolution supports Academic Senate *W Executive 16-14 Resolution Calling for Timely Notice and Scheduling of Provost Finalists' Campus Visits.⁴
