a. **HUM 310: Health Humanities**

i. Approval pending revision

1. In the alignment matrix, replace the “Course Objectives” with the appropriate “Student Learning Outcomes” in the second column;
2. Prerequisite: remove #6;
3. Insert “completion of 60 units” in #13.

b. **WMS 314: Feminism & Film**

i. Approval pending revision

1. The committee needs more specific assignments, such as readings, to be able to see the alignments of SLOs to existing Area F1 outcomes.
2. Insert “completion of 60 units” in #13;
3. Fix disconnect between #13 and #18; while there are no prerequisite courses, students do need to have completed 60 units;
4. Area G is likely to be removed from the GE package and the category of Cultural Pluralism shifted, at least temporarily, to a University requirement (similar to GVAR). If proposer would like to have the course included in what is now Area G, then they will need to show alignment of all of the existing outcomes, i.e., Area G 1 – 4.
5. The committee needs the correct class schedule; the one provided is for a different course.

c. **MUS 401: Afro American Music**

i. Approval pending revision

1. The course must align with **ALL** outcomes in Area F; the course is already approved for Area G;
2. The proposer should rename “Music Assessment” to “Student Learning Outcomes” in the matrix headings;
3. In a new matrix column, should include examples of assignments and readings to help the Committee understand how the Student Learning Outcomes will be met.

- d. **HUM 310: Introduction to Women’s Studies** **MC** **AP**
 - i. Approval pending revision
 1. Proposer should remove the “First Year Student...” statement from the Course description in the syllabus and should add “Change of Course Description” to their changes;
 2. The proposer should remove all references to Area D2; a course cannot apply for both subarea in Area D. If the proposer chooses to keep both areas, then the proposal may be denied.
 3. The proposer should remove all references to “mastery” levels in the syllabus (this is a 200-level course and “mastery” is not expected); a matrix aligning the course to basic skills is not currently required by the Committee.
